

## MEMORANDUM OF UNDERSTANDING

At Athens, this day of 11th November 2024, the following Parties:

1. The Free Movement Skateboarding (FMS) with VAT number 996809717 with registered office Feidippidou 25A, 15351, Pallini of the D.O.Y. Pallini legally represented herein by the President Mr. William Ascott
2. The Non-profit Civil Society under the name "**Non-Profit Organization IASIS**", with its registered office in Athens, 297 Acharnon Street, No. 297 and with Tax Identification Number 998821253 of the Tax Office of the Department of Tax Administration of Athens, which is hereby represented by its Vice President Mr. Nikolaos Balta. The mission of IASIS is, among others: to provide psychosocial support and the promotion of mental health, to support in crisis and emergency situations, to provide humanitarian aid, to combat social exclusion of vulnerable groups of the population, to provide psychological and counselling services, to create equal opportunities and new perspectives for vulnerable groups of the population, to provide psychiatric care in the community based on the principles of Social Psychiatry and Psychosocial Rehabilitation, to provide psychiatric care in the community based on the principles of Social Psychiatry and Psychosocial Rehabilitation, and to provide psychiatric services to the vulnerable groups of the population.

They jointly decide to sign a Memorandum of Cooperation, in order to undertake initiatives and synergies at the level of psychosocial support, education, research and development of innovative programs, organization of events and awareness-raising actions, etc., with the following specific terms.

### Article 1

#### Object of cooperation

This Memorandum of Understanding is intended to promote jointly the educational, research, scientific and social cooperation of the Parties. Indicatively, but not limited to, the scope of cooperation includes:

a) The cooperation of the Parties in the provision of psychosocial rehabilitation services, and in general mental health promotion and care in the Community based on the principles of Social Psychiatry and Psychosocial Rehabilitation. More specifically, within the framework of the service of the Day Centre for Youth Support "Connect Athens", FMS refers to AMKE IASIS beneficiaries to provide trainings through its certified training center, psychosocial support, psychological support, as well as jointly according to their expertise they can provide seminars for youth participants in the community, who can be served after evaluation by the professionals of the organization. Both parties cooperate to provide holistic support to the population through their services. At the same time, according to the expertise of both Parties, both assessing the needs of the population, they both design empowerment activities and group, such as implementing together sport sessions according to each one's expertise, that will be hosted both in the day center and outdoors and will be followed by the members of both Parties in order to mobilize and empower them.

- b) The strengthening of scientific cooperation through the planning, joint writing and co implementation of National and European programmes with the aim of funding both from the aforementioned sources and from the cooperation networks of the two Parties.
- c) Cooperation in European, national and international programmes of common actions and objectives.
- d) Jointly seeking funding through European, national and other programmes for actions of common interest.
- e) The strengthening of scientific cooperation through e.g. the production of publications, educational material, know-how, data, etc.
- f) The co-organization of actions and events and the dissemination of educational programmes with social impact.
- g) The promotion of the individual actions and projects of the agencies through the media and social media
- η) The co-organization of specialized actions related to the scope of Psychiatric Reform, and other related scientific fields
- i) The exchange of know-how, documented knowledge, theoretical elaborations and research experience.
- l) Any other research and/or educational activity for the common benefit and decided by consensus by the Parties.

## **Article 2**

### **Implementation**

1. Individual actions in areas where common educational, research, scientific and social interest is identified, will be decided and specified by the Parties in specific Protocols, in the framework of the present. The terms of cooperation for each specific activity arising hereunder will be considered and mutually approved by the Parties in writing prior to the commencement of such activity, and will be subject to specific agreements.
2. In these Protocols, a scientific officer will be designated by each Party as responsible for the coordination of the required actions in the joint actions and the optimal completion of their work.
3. The Parties mutually accept the respective criteria and procedures for quality assurance, assessment, validation and recognition of knowledge, skills and competences for the implementation of the Covenant of Cooperation.

## **Article 3**

### **Expected Benefits**

1. The implementation of the present Pact marks a new dynamic with benefits for both Parties, further contributing to the promotion of a more effective organisation and management of actions and programmes with social, educational and research impact.



2. At the same time, this cooperation will give prestige, scientific validity and methodological integrity to scientific, educational and other social actions.
3. The cooperation between the two parties can be mutually beneficial, since IASIS, apart from structured knowledge, can offer consultancy services, as well as trained volunteers and partners for a wide range of events and activities.

#### **Article 4**

##### **Dispute Settlements**

1. All disputes that may arise from the interpretation and/or implementation of this Covenant shall be settled amicably through discussions and/or consultations between the Parties and no dispute shall be referred to any national or international court or third party for settlement.
2. In any case, the disputes referred to in the preceding paragraph shall be subject to the agreement of the Parties in more specific bilateral agreements between them.

#### **Article 5**

##### **Obligations - Confidentiality Clause & Confidentiality**

1. This Agreement does not contain exclusive cooperation clauses, rights of first refusal or financial commitments.
2. The Parties undertake to maintain and handle all information brought to their attention in strict confidence.
3. This Covenant is without prejudice to discussions, negotiations or cooperation of the Parties concerned with other Parties on matters not related to the purposes of this Covenant as described in Article 1.
4. Any use of the names of the Parties, including any affiliated schools, departments, programs or logos, in any way related to the activities described in this Memorandum of Understanding shall be subject to prior written approval.

#### **Article 6**

##### **Entry into force - duration of validity - amendments**

1. This Memorandum of Understanding shall enter into force on the date of its signature and shall have an unlimited duration.
2. Either Party reserves the right to terminate this cooperation prior to its expiration upon giving at least sixty (60) days prior written notice to the other Party.

3. This Cooperation Agreement may be varied or amended by mutual written consent between the Parties.
4. The termination of this Memorandum of Understanding shall not affect the action programmes established on the basis of this Memorandum of Understanding and already in progress until their expiry.
5. Recurring programmes shall not be automatically renewed in the event of termination of this Agreement.
6. The obligation of confidentiality - security confidentiality as set out in Article 5 shall remain in force even after the termination of this MoU.

This Memorandum of Understanding is fully understood by the Parties and is signed this day in four (4) copies of which two (2) shall be received by each Party.


